

2026 Rockdale Fair Association Children's Pageant

Rules and Application

Age as of September 1st: Tiny/Little Masters (3-5) * Tiny Tot Jr Master/Miss (3-4) * Tiny Miss (5-6) * Little Miss (7-8) Young Miss (9-10) * Junior Miss (11-12) * Teen Miss (13-15)

RFA reserves the right to adjust the age divisions. Contestants will compete in the category to which they are assigned.
Note: Five entries are required for each group. Entry fees will be refunded if less than five.

1. Residency: Must live in or attend school in Milam County.
2. Entry Fee: \$15.00 – cash or check made payable to Rockdale Fair Association
3. Deadline: **Wednesday, September 16th. NO EXCEPTIONS!** Mailed entries must be postmarked by September 16th. NOTE: USPS has changed guidelines about postmarks – may take more time due to processing – MAIL EARLY or take into post office to be postmarked manually at window. I will do random Walmart parking lot pickups – check RFA FB page/emails/messages – TEXT is my preferred communication. I send plenty of reminders!
4. Dress: Western wear (AGE APPROPRIATE – length appropriate for being on stage above audience – can and will be turned away at check-in if not appropriate – no refunds – if in question, check outfit with coordinator ahead of time.
5. TEEN MISS WILL SPEAK and/or ANSWER AN ON-STAGE QUESTION.
6. MANDATORY pictures and practice: **Sunday, October 4th** at RHS auditorium beginning at 12:30 pm (subject to change) for all categories. **NON-ATTENDANCE WILL RESULT IN DISQUALIFICATION.** You will need to plead your case with Kris Moreland at 512-430-2767 before October 4 if there are any issues. NOTE: exceptions to this rule are exceedingly rare.
7. Pageant: **Saturday, October 10th** at 12:00 (subject to change) at RHS auditorium. Arrival time for all categories will be announced. Actual start time will be determined based on number of entries.
8. Parents and guests ages 5 and up must have a ticket to enter – available at door.
9. Judging: based upon natural personality, confidence, general appearance/dress. Judges are from out of town. Title holder and first and second runner-up are awarded in each age division.

Violation of any Rockdale Fair rule, or misconduct by contestant or parent/guardian, will serve as a disqualification of contestant from the pageant and any RFA activities for the current year and/or future years if the RFA deems it necessary.
